The minimum specific experience as a prime contractor in construction works of at least 1(one) number of similar natures of any building related works successfully completed within the last 05 (Five) years with a value of at least Tk. 6.00 (Six) lac in single contract under Government/ Semi Government/ Autonomous Organization of Bangladesh.
3. The required average annual construction turnover shall be greater than Tk. 6.00 (Six) lac in the last 5 (Five) years. Payment certificates for contract in progress or completed under public sector during last 5 (five) years must be submitted along with the tender in support of average annual construction turnover.
4. The Tenderer must have a minimum liquid assets/ working capital/credit facilities (in the PW2A-8 Form Published by BPPA) Tk. 05.00 (Five) Lac.
5. The minimum Tender Capacity of the Tenderer shall have Tk. 6.00 (Six) lac
