The Tenderer shall have a minimum amount of Financial Resources of BDT 50 Lakh, in the form of Liquid Assets, Working Capital, Credit Line(s), Specific Credit Commitment(s), or any combination thereof. The certificate must be issued between the date of publication of the Invitation for Tender (IFT) in the e-GP System and the Tender Submission Deadline, and shall be submitted in the prescribed format of e-PW2A-8.
 11. The Minimum Tender Capacity of the Tenderer shall be BDT 50 Lakh.
 12. The required Average Annual Turnover from manpower supply services through the outsourcing system under Bangladesh Police Units shall be at least BDT 35 Lakh over the last 03 financial years. This shall be supported by Certified Payment Certificates received against completed contracts under Bangladesh Police Units during the last 03 years.
 13. Priority will be given to the Harijan community in the procurement of cleaning services.
