- The required average annual construction turnover under public sector shall be greater than Tk 30.00 Crores over the last 05 (five) financial years; Document must be submitted along with the tender in support of average annual construction turnover.
- The minimum amount of financial resources as liquid asset or working capital or credit line(s) or specific credit commitment or in any combination of them, of the Tenderers shall be Tk. 07 crores. Liquid assets i.e working capital or credit line(s) original certificate must not be issued before 2 (Two) months since the date of the tender opening and the tenderer should follow the Form as per BPPA format for line of credit.
- The minimum capacity shall be: Tk.21.00 Crores, Supporting information must be filled up as per enclosed form (list of ongoing works/commitments) All other conditions as mentioned in e-TDS & PCC of e-tender document must be fulfilled.
- The tenderers must enclose Up-to date VAT Registration certificate, Income Tax certificate and Trade License as well as Other required eligibility and conditions of the Tender as shown in Tender Data Sheet (TDS).
