 - The satisfactory completion of supply of similar types of goods i.e. uPVC pipe and uPVC fittings of minimum Tk. 17.00 (Seventeen) lakhs under Single contract in the last 05 (Five) years. i.e. years counting backward from the date of publication of IFT in the e-GP System. The certificates should be issued by an officer not below the rank of Executive Engineer. The certificate must contain the name of the officer, address, telephone number and email address.
 - The minimum amount of liquid asset or working capital or credit facility is Tk.17.00 (Seventeen) lakhs. ISO 9001:2015 for quality management systems in respect of manufacturing of uPVC Pipe.
 - The Tenderer must submit all the required papers and documents to proof their eligibility as per tender documents (including Technical specifications and Special terms and conditions). All completion certificate for general experience, specific experience enclosed with tender document must have issued by the Government/Semi-Government organization or any autonomous body/organization of Government.
