The required **Average Annual Construction Turnover shall be minimum Tk. 100.00 (One Hundred) lac over the period of last 05 (Five) years** i.e years counting backward from the date of publication of IFT in the newspaper. Average Annual Construction Turnover i.e total certified payments received for contracts in progress or completed under public sector shall only be considered. Private works, payments received for Goods & Services will not be taken into account.

3. The minimum amount of **Liquid Assets i.e. working capital or credit facilities of the Tenderer shall be Tk. 60.00 (Sixty) Lac**. The liquid asset certificate issued before IFT will not be considered for evaluation.

4. The minimum **Tender Capacity shall be TK. 100.00 (One Hundred) Lac**.
