 - The minimum amount of liquid asset or working capital or credit facility is Tk. 90.00 (Nineteen) lakh.
 - The Tenderer will have to submit a bank transaction sheet of his firm/company's account showing balance of minimum Tk. 90.00 (Nineteen) lakh for at least in a single day after published the tender at E-GP system.
