The minimum supply & setting value of similar goods (0.5/1.0 cusec or above solar system used in irrigation purpose) under Single contract in the last 05 (Five) years is Tk. 90.00 (Nineteen) lakh
- The certificates should be issued by an officer not below the rank of Executive grade. The certificate must contain the name of the officer, address, telephone number and email address.
- The minimum amount of liquid asset or working capital or credit facility is Tk. 90.00 (Nineteen) lakh.
- The Tenderer will have to submit a bank transaction sheet of his firm/company's account showing balance of minimum Tk. 90.00 (Nineteen) lakh for at least in a single day after published the tender at E-GP system. ISO 9001:14001 or latest Certificate in favour of the manufacturer of goods is required.
