3. Tenderers must have liquid asset amounting TK. 52,000 (fifty-two thousand) tk only in the form of PG2-5, (time will be counted backward from the date of publication of IFT in e-GP system)

4. Up-to date Trade License, up-to date Income Tax Clearance and up-to date VAT Registration Certificate .

5. High quality Purchase of Training materials must be supplied
