Having experience as a Prime Contractor or Subcontractor or Management Contractor in successful completion of at least 1(one) number of Civil works to in a single contract durring last 5 (five) years with a value of at least BDT. 3.00 Lakh in any Government/ Semi-Government/ Autonomous Organization of Bangladesh.In case of the work done under PWD, the certifying and authenticating authority shall be the concerned Executive Engineer. 3. The tenderer shall have minimum BDT 16.00 Lakh average annual construction turnover during last 5 (five) years. Payment certificates for contracts in progress or completed		

under public sector must be submitted along with tender in support of average annual construction turnover.

4. The minimum amount of liquid asset or working capital or credit facilities of the tenderer shall be BDT3.50 Lakh. Document submitted along with the tender must be issued in between publication date and submission date of the tender. Letter of Commitment for Bank's Undertaking for Line of Credit as per form PW2a-3 of Tender and Contract forms section must be submitted for this purpose.
