(e) Up-to-date Valid Trade License as supplier.
(f) e-BIN (13 Digits) Registration Certificate.
(g) Certificate of incorporation (in case of limited company).
(h) Manufacturer authorization letter or contract deed with the importers/manufacturer (if the bidder is supplier) [When Applicable].
