5) Scanned copy of original liquid asset document (certificate or statement from bank issued not earlier than the date of publication of IFT in e-GP website) in the format designated in PPR.

6) The credit facilities should be sanctioned in favor of contractor and issued not earlier than the date of publication of IFT in e-GP website by any scheduled bank of Bangladesh in accordance with ITT clause 14.1(b) without alteration and must submit in the format of credit line (Form PW 3-7).

7) Tenderer should submit the information related to 'Tender Capacity' as per standard format of BPPA.
