    - i) In case of work done under PWD, the certifying and authenticating Authority shall be the Concern Executive Engineer.
    - ii) In case of the work done under any Govt/ Semi Govt/ Autonomous Bodies/ Organization other than PWD the certifying authority shall be an officer not below the rank of Executive Engineer
  - c) The Tenderers must have a minimum average annual Construction Turnover of Tk 3.80 lac during last 3 (three) Years.
  - d) The minimum amount of liquid assets or working capital or credit facilities of the Tenderer shall be Tk 6.00 lac only.
